- ✓ **Deadline: Completed applications must be submitted no later than Nov. 15, 2019**

- ✓ Provide a clear description/photo of the signage/display/tent you intend to utilize.
- ✓ Generators and extension cords are allowed as long as they are contained within your

vendor area and as long as the noise level of the generator does not adversely affect adjoining neighboring vendors. If your generator is needed for your vendor practices, please note that if it is noticeably noisy, Englewood Beach Waterfest, Inc. reserves the right, at its sole discretion, to ask you to not use it. In the event you are asked to discontinue use of your generator, your vendor fees will NOT be refunded.

- ✓ It is understood that the Englewood Beach Waterfest is an outside event and that inclement weather could result in delays and/or cancellations. There will be no refunds for any days where the intended events are affected by inclement weather.
